Re: 2026 Goat ProjectInformation and Updates

This is a quick update on the events that will take place for the 2026 fair season within the goat department. Should you have questions, please feel free to contact the MSU Extension Office at 269-467-5511. Please note that the information contained in this letter is subject to change.

NEW for 2025:

- **Breeding stock goats and market goats designated for take-home** may be loaded out Saturday, September 26, from 11:00 p.m. to midnight.
 - All goats **MUST** be loaded out by **8:00 a.m.** Sunday, September 27
 - The St. Joseph County Grange Fair will NOT require loadout to be done by 11:00 a.m. on Sunday, September 27. There will not be fireworks or rides operating that day.
 - **ALL YOUTH** are still expected to be at barn clean up at 5:30 a.m. on Sunday to tear down gates and clean specie barns. Fines will be enforced!
- Goat pens must be cleaned a **minimum of 2 days** during fair week.

Reminders:

- Dairy goats and meat goats will show in **separate rings** with separate judges. Both rings will run the same show order: 4-H exhibitor meeting (all together), Showmanship (oldest to youngest), Cloverbuds, Market Classes, Breeding Classes, County Bred & Born, Pet Class.
 - Anyone is allowed to prepare animals for presentation for show. However, it is expected that 4-H, FFA, and other youth members **will actively participate** in the grooming of their project animal.
 - All breeding stock animals must be registered at the MSU Extension office by August 15 via FairEntry.
- **Market Goats**
 - Dairy Market Goat project animals are limited to the following breeds: Alpine, Guernsey, LaMancha, Nubian, Nigerian Dwarf, Oberhasli, Saanen, and Toggenberg.
 - Meat Goats are any goat that is not included above. Example: Boer, Angora, Fainting, etc. or crossbred with a dairy breed.
- **Market Goat County Bred & Born** class goats must be both bred and born in St. Joseph County. County Bred & Born forms must be filled out at countywide registration in June. Exhibitors may only show one animal in this class.
- Market and carcass **goats MUST HAVE milk teeth** present at time of fair weigh-in. Animals without milk teeth are ineligible for market/carcass exhibition at the fair and will be sent home at weigh-in. We recommend market/carcass goats be born by December 1, 2025 or after.
 - **Exception:** Does may be exhibited as breeding stock if the member chooses.
- **Live carcass weigh-in** will be Saturday, September 12, 2026, from 10:00 - 11:00 a.m.
 - Goats must weigh a minimum of 60 lbs. Underweight goats will be sent home at weigh-in.

- **Goat Carcass hanging evaluation** contest will be the week of September 14, 2026, at Bontrager's Custom Meat Processing in Leonidas, actual date and time to be determined.
 - Exhibitors are required to attend the hanging evaluation unless prior approval is granted by the 4-H Program Coordinator. No-shows will result in disqualification.
- Every market goat must weigh a **minimum of 60 lbs.** at time of weigh-in on **Saturday, September 19, 2026.** Underweight animals are ineligible for exhibition at the fair and will be sent home at weigh-in.
 - **Exception:** Does may be exhibited as breeding stock if the member chooses.
- Michigan Department of Agriculture and Rural Development (MDARD) requires all goats that are moved off the farm for sale or exhibition to be **ear tagged** with a USDA Scrapies ID tag. Earless goats must have a collared tag. **Anyone purchasing goats should make sure the seller has tagged them prior to sale.** If you raise goats from your own herd you should contact the MDARD at 1-800-292-3939 to get a premises identification number. Once you have the premises number call the USDA at 1-866-873-2824 to get your tags.
- **All 4-H livestock members/clubs** will be held responsible for setting up their project pen/stall and decorations before fair, as well as cleaning and tearing down their project pen/stall at the end of fair. Individuals or clubs may be assessed a \$50.00 fine for failure to do so.
