For products that may need a surfactant, a non-ionic surfactant at 0.25 to 1% v/v is the typical recommendation. Consult the herbicide label to verify the type and rate of surfactant to include. AMS should be included with glyphosate in all applications at 17 lb/100 gal to improve activity, unless otherwise prohibited with certain tank-mix partners.
